Sub: My appointment as Scrutinizer for Postal Ballot

Ref: Your Letter dated 05.09.2011

In terms of your above referred letter, I have been appointed as the Scrutinizer to scrutinize the postal ballot forms sent by the Company to the shareholders in respect of the Ordinary Resolution under Section 293 (1) (d) of the Companies Act 1956 to increase the borrowing powers of the Board of Directors to a sum not exceeding Rs. 500 Crores over and above the aggregate of paid up capital of the company and its free reserves at any time.

I note that as per the instructions and conditions attached to the said Postal Ballot, duly completed postal ballots should reach the scrutinizer not later than the close of working hours (5pm) on Saturday, 22<sup>nd</sup> October, 2011.
