Sub: Notice of Resignation from the Board of Directors under Section 168(1) of the Companies Act, 2013 with effect from October 11, 2021.

Sir

This is to submit my resignation from the Board of Muthoot Capital Services Ltd. with effect from October 11, 2021.

Reasons for resignation

1. As intimated to the Board earlier, I had taken charge as Chief Principal Secretary to the Hon'ble Chief Minister of Kerala on May 25, 2021. This new responsibility has imposed considerable pressure on my work schedule. I am also holding in addition to the aforesaid office, two official positions viz. the Chief Executive officer of the Kerala infrastructure Investment Fund Board and the Executive Vice Chairperson of the Kerala Development and Innovation Strategic Council (KDISC), a body chaired by the Hon'ble Chief Minister. KDISC has been also recently assigned the responsibility of serving as the functional secretariat of the newly announced Kerala Knowledge Economy Mission.

With the load of responsibilities increasing significantly in the last one month, I am unable to devote as much time as is expected of an independent member to fulfil the responsibilities or do justice to the duties cast upon me under the Companies Act 2013.

2. MCSL is a registered company with its head office in Kerala, with most of its operations in the State of Kerala. On careful analysis and reflection, I realize that there might be several regulatory or commercial issues in which MCSL or other group companies might have to interact with Government and obtain decisions or interventions from Government. In keeping with the highest standards of independence, transparency and integrity contemplated under the Companies Act, 2013, it is necessary to avoid any conflict of interest between my role as the Chief Principal Secretary to the Hon'ble Chief Minister of Kerala and my role as an independent member on the Board of MCSL.

I hereby confirm that there are no other material reasons for my resignation other than those provided above.

I am grateful to the Chairman and Managing Director for giving me this opportunity to be an independent Member on the Board over the last two years.

I would also like to express my sincere thanks for the support as well as my appreciation for the staff of MCSL, particularly the Chief Financial Officer, Chief Operating Officer and the Company Secretary and their teams for their dedication and professionalism in the conduct of the affairs of the Company.

Finally, I would like to place on record my gratitude to the other Directors on the Board of MCSL for the kind support and warmth of the relationships I have enjoyed in the Board Meetings of MCSL.

I request that the required details in Form DIR 12 may be filed with the Registrar of Companies to complete the required formalities of resignation.
